Amendment to the Revised Examination Regulations for the Master of Arts in Journalism, Media and Globalisation at the Faculty of Business, Economics and Social Sciences at Universität Hamburg

dated 11 July 2012

On 16 September 2014 in accordance with Section 108 subsection 1 of the Hamburg higher education act (Hamburgisches Hochschulgesetz, HmbHG), the Executive University Board of Universität Hamburg ratified the Amendment to the Revised Examination Regulations for the Master of Arts in Journalism, Media and Globalisation adopted by the Faculty of Business, Economics and Social Sciences on 11 July 2012 pursuant to Section 91 subsection 2 no. 1 HmbHG dated 18 July 2001 (HmbGVBl. p. 171), as amended 20 December 2011 (HmbGVBl. p. 550).

Section 1

The Revised Examination Regulations for the Master of Arts in Journalism, Media and Globalisation dated 13 July 2011 shall be amended as follows:

In the last sentence of the preamble, the words “or as a double degree in cases where a joint degree is not possible” shall be deleted.

In Section 1 subsection 2 after the words “Upon passing the master’s degree program in accordance with Section 13 et seq. herein, the Faculty of Business, Economics and Social Sciences at Universität Hamburg (hereinafter: Faculty),” the following shall be

inserted into the text, “, together with the Faculty of Humanities at Aarhus University,”.

Section 21 shall be amended as follows:

“Transcript of records, diploma, and diploma supplement

(1) A transcript of records of the master’s degree program shall be promptly issued after the last exam has been passed, if possible within four weeks thereof. The transcript of records shall contain information about completed modules, the topic and grade of the master’s thesis, the overall final grade, and aggregate ECTS credits earned as well as the ECTS grade in accordance with Section 17 subsection 7 herein. The transcript of records shall be signed by the chair of the Examinations Board and affixed with the seal of the university issuing it. The transcript of records shall bear the date on which the last exam was taken. It shall be issued in English and upon student request also in German.

(2) In addition to the transcript of records, the candidate shall also receive a diploma in English conferring the master’s degree dated the same date as the transcript of records. The diploma shall be signed by the Dean of the Faculty of Business, Economics and Social Sciences from Universität Hamburg and the Dean of the Faculty of Humanities from Aarhus University and affixed with the seal of the respective university issuing it. As common practice, the student shall also receive a German translation of the diploma.

(3) In addition, a joint diploma supplement shall be issued in English containing information about program content, course of study, and the academic and professional qualifications acquired through the degree.”

Section 2

The amendments to the Examination Regulations shall become effective on the day following official publication. It shall first apply to students commencing their studies in Winter Semester 2013/14.
